Greetings,

October is here and that means the fish will be putting on their fall feedbags and it also means that it is time for our first meeting of the season, see details below and we hope to see you there. We won't be having any speaker for our first meeting, but we are very excited to have a great speaker lineup so far for most of the other dates; thank you to Karen for working so hard in getting these booked.

We will most likely be discussing some of the following fishery's information during our first meeting but I wanted to share some of it with you incase you are not able to attend. On September 27th, the Minnesota DNR released over 2,100 fingerling sturgeon at Chambersburg Park in Fond Du Lac. All of the fish were implanted with PIT tags and should reach catchable size in about 20 years. The Fond Du Lac tribe also released a comparable amount of fingerlings in the Cloquet River as well.









Our tournament was quite successful with a total of 17 teams and 3 quality fish caught. More of the details about this will be discussed during our first meeting but we were able to raise about

\$2,400 which is great. First place went to Joe Grupa/Keegan Mcintosh with the 45", second place Curt Ellestad/Tony Sonneman with a 42", and third place Ken Vesel/Todd Williamson with a 40.75". Congratulations to those folks and we hope to see you back next year!







Muskie Inc. Members Only Fishing Contest Rules and Regulations for 2024

- 1. Muskie must be caught on legal sport fishing tackle (hook & line) in the United States or Canada in strict compliance with all local, state, or provincial laws. Release division: 30 inch minimum. Kept division: That length set by the governing agency of that body of water.
- 2. Muskie must be hooked and played by only one person, and only that person may enter the Muskie in the contest. Assistance in landing is permitted
- . 3. Entrant must be a member in good standing of Muskies Inc. prior to catching the Muskie.
- 4. All entries must be mailed to their chapter contest chairperson and postmarked within 30 days of the date of catch. Members may enter their own catches directly on the Web Site. All entries for Nov. and Dec. must be received by the international chairman by Jan. 10. Unaffiliated members should mail their entries to the international chairman within 30 days of the date of catch.
- 5. Release Division: 30-inch minimum for all bodies of water. A release patch and/or an individual certificate will be awarded for each Muskie 30 inches or longer that is released. Please indicate your desire to receive these on the front of the entry form.
- 5A. The longest Muskie released in the men's division, women's division, and the junior division will receive a free replica of their Muskie courtesy of Fittante Replicas of Antigo, WI. (Total of 3 per year) This is the longest by total inches including fraction of inches. At least one verifiable witness and at least one verifiable side view horizontal photograph of the Muskie is required.
- 6. The international contest committee will review all entries for validity and their decisions will be final. At its discretion the committee may require additional documentation consisting of a photograph and/or a 2nd witness before an entry is accepted.

International Awards.

- 1. Men's Masters 10 Awards. Any male member who has recorded 250 or more releases in the Lunge Log.
- 2. Women's Masters 2 Awards. Any female member who has recorded 100 or more releases in the Lunge Log.
- 3. Men's 10 Awards. Any male member 18 years of age or older with less than 250 releases.
- 4. Women's 10 Awards. Any female member 18 years of age or older with less than 100 releases.
- 5. Juniors 10 Awards. Any male or female member 17 years of age or less on January 1 of a calendar year.
- 6. Lunker Of The Month Longest release by any member of Muskies, Inc. All ties qualify.

Men with less than 250 and Women less than 100 on January 1 of a calendar year will remain in that division for the year.

Release Points are based on 4 points for each release and 1 point for each inch over 30 inches. Any measurement of 1/2 inch or longer will be rounded up. Any fraction of less than 1/2 inch will be dropped.

- : 1. The Muskie must be a minimum of 52 inches in length.
- 2. Fish must be measured on bump board and photograph with fish on bump board.
- 3. Photographed and the photo sent to the contest chairperson within 30 days of the catch via mail or email. Photos will not be returned. Photos can be digital or via a smartphone. Please sent via email.
- 4. Muskie registrations without pictures will not be eligible for the award.
- 5. All entries must be recorded on a Muskie Inc. Fishing Contest Entry blank or entered online at www.muskiesinc.org. Entry blanks are found at the Muskies Inc. website or are available from your Fishing Contest chairperson.
- 6. Fishing Contest Entry blanks (paper or online) must be: A. FILLED OUT COMPLETELY on the front page or online to be eligible for points or awards. This includes the name of the body of water and bait used. THIS REGULATION WILL BE STRICTLY ENFORCED TO COMPLY WITH THE PURPOSES OF MUSKIES, INC. B. Witnessed by at least one person and must have the phone number and signature of that witness. C. 2024 Rules for the Lunker of the Month

Lunker of the Month Awards is for the largest released Muskie for each month. The angler releasing the largest Muskie in that month will receive a Lunker of the Month Award.

The rules are as follows:

- 1. The Muskie must be **40** inches or longer for adults and 30 inches for junior members. There will be one award overall per month (not a separate award for adults and juniors).
- 2. Photographed and the photo sent to the contest chairperson within <u>30 days</u> of the catch via mail or email. Photos will not be returned. Photos can be digital or via a smartphone, however, digital is preferred.
- 3. Muskie registrations without photos will not be eligible for lunker awards.
- **4.** All entries must be recorded on a Muskie Inc. Fishing Contest Entry blank or entered online at www.muskiesinc.org. Entry blanks are found at the Muskies Inc. website or are available from your Fishing Contest chairperson. Entry blanks may be copied for recording additional Muskies caught.
- 5. Fishing Contest Entry blanks (paper or online) must be:
 - 1. FILLED OUT COMPLETELY on the front page or online to be eligible for points or awards. This includes the name of the body of water and bait used. THIS REGULATION WILL BE STRICTLY ENFORCED TO COMPLY WITH THE PURPOSES OF MUSKIES, INC.
 - **2.** Entered online or received (via mail) by the Lake Superior Chapter Contest Chairperson within <u>30 days</u> of the date of the catch.
- **6.** In case of a tie, the winner for the month will be decided by their next biggest fish caught during that month. In case of a 2nd tie, winner will be decided on a coin flip.
- 7. You must be a member of the Lake Superior Chapter #33 in good standing for <u>45 days</u> prior before entering. If the membership is a renewal, it must be completed prior to the expiration date. If a transfer from another chapter, the **45-day** waiting period applies from the date of transfer.

Contest review committee will consist of at least 3 members which will include the following: Lake Superior Chapter Contest Chairperson and at least 2 other members (one of which will be a non-board member). The committee will be established to review all disputes or questions on entered Muskies. They will arbitrate any dispute and their decisions shall be accepted as final.

Chapter 33 Muskies Inc - Lake Superior Muskies Inc

The Lake Superior Chapter of Muskies, Inc. will be continuing our Wednesday Night Fishing Outings this year. The purposes of the outings are both educational and social. The Outings are designed to have some fun, to get newer members of the Chapter together with more experienced members, and also help the Chapter recruit new members. This is a chance

to fish with more Chapter members and get better acquainted with the folks who share our passion for Muskie angling.

We all bring different skills to Muskie fishing and to group operations. It will be wonderful if we can share these talents to improve our Chapter and our sport. The Wednesday Night Fishing Outings will encourage everyone who wishes to enjoy the good Muskie fishing in the Duluth area, members and non-members alike. Whoever shows up at the designated landing on the St. Louis River will be able to participate.

Records will be kept for those who wish to do so by using the Muskies, Inc. scoring methods of counting 30-inch fish or longer. A thirty inch fish = 4 points and one additional point for every additional inch. Example: a 40" muskie = 14 pts. Muskies are counted to the nearest quarter inch. Points will be scored based off of the Muskies Inc. rules. Also for the purpose of recording successes, digital pictures would be appreciated, so we have a visual record of this Chapter activity.

Recognition will be given the anglers who earn the most points for their five largest fish at the end of the season in the Newsletter and/or at Chapter meetings. Each person will be fishing for his or her individual points. These are friendly outings with no teams, established groups or awards.

A major emphasis of the Wednesday Night Outings will be to encourage participants to fish with different anglers each week. This will allow anglers to fish with and share knowledge with a variety of other people. If the parents of participants under the age of 18 agree,

the young anglers may fish with other Wednesday Night outing participants. They may also fish with their parents on every Wednesday Fishing Night if they wish. Parents with their youngsters in their own boats are encouraged to invite a different angler to fish with them each time they attend the Wednesday Night Outings.

The boat access is on the St Louis River, near the lift bridge area.
